# Innovation is key to economic success Ro Khanna

The recent passing of <u>Neil Armstrong</u> reminded us about the power of a common goal to rally our country. Fittingly, even longingly, many Americans ask: What might that common goal be today?

If the Soviet Union challenged American values in the 1960s, then China - which is presiding over censorship of the Internet, human rights abuses and currency manipulation - now presents the greatest challenge to the American model of an open, free society. How can we win the battle of ideas?

President <u>John F. Kennedy</u> challenged our technological elite - engineers, scientists and astronauts - to win the space race. Today, our challenge is more difficult. It is no longer enough for our military, government institutions and universities to use taxpayer funds to outcompete their foreign counterparts. Economic and technological growth have been decentralized. To win in a global economy with billions of potential new entrants, nearly every American citizen has to be more technologically creative.

We must become a nation of innovators.

We already are locked in a race to develop the fastest broadband, the newest alternative energy sources, the latest <u>cars</u> and planes, the next generation of computers and media, sophisticated machinery and improved medicine. It's no longer just about being the first to orbit the Earth or land on the moon. Government institutions alone cannot win this race. To succeed, we need an innovative, dynamic workforce that, of course, is supported by smart federal and state governmental policies.

For my book, I surveyed more than a dozen successful U.S. manufacturers to try to understand what makes them tick - and how they are thriving when many consider American manufacturing dead in the water.

What I learned is that to compete in a global economy, the best American manufacturers expect innovation at every level - on the assembly line, in middle management, by the executive team. This echoes the conclusions of <a href="https://doi.org/10.21/2

By becoming a nation of innovators, we can add value to our products at each level of manufacturing and distribution. This gives us a productivity advantage over lower-wage countries such as China.

So how do we get there?

As a first step, our leaders should call for every citizen to embrace innovation. Some ideas put forward by Ben Casnocha and <u>Reid Hoffman</u>, the founder of LinkedIn, are instructive. They say: All of us have to become lifelong learners and entrepreneurial in our approach to our careers. We must constantly think about how to add unique value to whatever tasks we undertake.

This is a lot to expect. To make it happen, our government has to do its part. We must find

common ground concerning government's role in helping encourage nationwide innovation.

Practically, this means:

- -- Ensuring every citizen has access to quality <u>education</u> after high school, whether it's college or vocational training, and that this education is tailored to jobs that exist in the marketplace.
- -- Empowering teachers to use technology in every classroom.
- -- Funding government institutions that do basic research, such as DARPA (<u>Defense Advanced Research Projects Agency</u>), ARPA-E (Advanced Research Projects Agency-Energy), NIH (National Institutes of Health), NSF (<u>National Science Foundation</u>), and in our own backyard, the Lawrence Berkeley and Livermore national laboratories. These institutions develop groundbreaking technology that can help spawn startups and provide existing American companies with a competitive edge.
- -- Providing immigrants who are contributing to our country's innovation with green cards and a path to citizenship. Consider the contributions of <u>Andy Grove</u>, Sergey Brin and Elon Musk. Enough said.
- -- Streamlining bureaucracy and providing tax incentives to start new companies.

These policies are not comprehensive, but they are critical to ensuring our economic competitiveness for this century. They require the same resolve that our nation had for the space program in Kennedy's time.

We need once again to show that institutions of self-governance work, and are capable of achieving great objectives. Using government policy to empower messy, bottom-up technological progress will require more finesse than directing the nation to achieve a single, big goal.

If we succeed in democratizing innovation, this century could be our greatest - both economically and technologically. From the perspective of contributing to human knowledge, 21st century America would be akin to Renaissance Florence. My generation would, then, have earned its chapter in the great American story.

# No doubt about McNerney... Seasoned congressman has immersed himself in S.J. County issues

We would contrast his 25-year-old opponent, Ricky Gill, a bright, well-spoken man seeking his first elected post. Gill lacks even a scintilla of public experience, save his service as an appointed student representative on the state school board when he was in high school. Further, since he graduated from law school earlier this year, he lacks any demonstrated work experience, aside from his campaign claims to have "worked on his family farm" growing up.

Gill says, "We need more statesmen in Congress," but even before being elected he has signed the infamous Grover Norquist anti-tax pledge that essentially removes negotiation from the bargaining table. He told The Record's editorial board he would stand by that pledge even if the nation went to war.

This is not to suggest Gill isn't bright. He most assuredly is. Nor is he a flamethrower. But his level of naïveté and being born privileged at times makes him seem dismissive of just how tough some Valley residents have it.

McNerney has had tough times. He has been laid off from a job. For that matter, he had actual jobs before launching his public service career.

He's earned a doctorate, raised children (including a daughter who this year earned a doctorate). And since becoming a congressman for this area, he has immersed himself in the issues facing this area, especially water, agriculture and services to veterans.

One area where we split with McNerney is in his support of the high-speed rail system. But even on this issue he makes reasoned argument that by being first in the nation to build a high-speed rail system this state can create the engineering and manufacturing expertise that the rest of the nation could adopt.

McNerney should be sent back to Congress.

# Garamendi Highlights New Kaiser Study: Californians Would Pay \$100 per Month More in Medicare Premiums Under Ryan-Republican Plan

Oct 16, 2012Issues: Economy, Health Care, Seniors, Social Justice

FAIRFIELD, CA – Congressman John Garamendi (D-Fairfield, CA), California's Insurance Commissioner for eight years, today highlighted a new <u>report by the Kaiser Family Foundation</u> that shows California seniors would, on average, face an increase of over \$100 per month in traditional Medicare premium costs under the Ryan-Republican plan to replace Medicare with an underfunded voucher system. The study also found that removing the Medicare guarantee and replacing it with a voucher or "premium support" system would produce higher premiums for six in ten American seniors.

The Kaiser study only evaluates increased premiums and does not take into account the additional out-of-pocket costs that seniors would incur from higher co-pays and deductibles and from losing the free preventative care and prescription drug discounts included in the Affordable Care Act.

"California's seniors, and every Californian who will become a senior, have good reason to be concerned about the changes to Medicare that almost every Republican in Congress voted to implement," said Congressman Garamendi, who has made protecting the Medicare guarantee a top priority. "The Ryan-Republican plan to end the Medicare guarantee would raise premiums paid by California seniors in the traditional Medicare program, on average, by at least \$1,200 a year. This is effectively a regressive tax increase targeting middle class and lower income seniors, and so long as I'm in Congress, I'll do all I can stop their plan from becoming law."

### Congressman Pete Stark

### Rep. Stark Announces EPA Grants to Bay Area Water Quality Projects

WASHINGTON – Today, Rep. Pete Stark (D-CA) released the following statement in support of the Environmental Protection Agency's (EPA) awarding \$6.5 million in federal grants to ten projects in Northern California. These grants, provided to state and local agencies as well as non-profit organizations, will be used to improve water quality and restore habitat throughout the San Francisco Bay watershed. They are funded through the San Francisco Bay Water Quality

Improvement Fund, which has invested \$28 million in various clean water projects since 2008 and leveraged more that \$103 million in additional funds.

"I am very pleased with the Environmental Protection Agency's decision to award these funds to water quality projects in the Bay Area. I have spent my entire career fighting to clean up the Bay and protect our environment and I have worked to bring federal funds back to our area to do so. The Bay is a national treasure. These grants will help make sure it is healthy enough for our children to fish and swim in."

Two of the grants awarded today are for projects located in Rep. Stark's 13th Congressional District. The EPA allocated \$500,000 to continue the restoration of the South Bay Salt Ponds in partnership with the California Coastal Conservancy. Additionally, \$181,000 was awarded to improve the health of Alameda Creek in partnership with the Alameda County Resource Conservation District.

In 2010, Rep. Stark worked to obtain \$1 million in federal funding to support Salt Pond restoration. In 2009, Rep. Stark secured \$1,337,000 in funding to improve wildlife habitat in the Alameda Creek watershed

# **DeSaulnier Responds to Veto of Transportation Inspector General Bill** SB 878 Vetoed by the Governor

Today Senator Mark DeSaulnier (D-Concord) announced his disappointment in the Governor's veto of Senate Bill 878. SB 878 would have created the State Office of Inspector General (OIG) to oversee transportation agencies with projects funded with state dollars. SB 878 received wide bipartisan support in the Senate with a vote of 35-0.

"I am very disappointed in the Governor's veto. The limited oversight that SB 878 would have provided over billions of taxpayers' dollars, would have helped to regain the public's trust in how the State spends their money," said DeSaulnier. "This bill is a modest first step to assure that we are getting the most out of our transportation dollars."

The California Transportation Commission is responsible for adopting the five-year State Transportation Improvement Program (STIP), which is the funding plan for future expansion projects on the state highway system. The most recent STIP consists of more than \$3 billion to be allocated and spent over the next five years. These funds, once allocated, are spent by various state and regional entities with relatively little oversight.

"Billions of dollars are spent each year on California's transportation infrastructure," said DeSaulnier. "We are operating in a challenging world of shrinking transportation revenues and increasing demands. It is imperative that we make every transportation dollar go as far as possible."

SB 878 establishes the Office of the Inspector General to ensure the California Department of Transportation, the High Speed Rail Authority, and all other state, regional, and local agencies that use state transportation funds are operating efficiently, effectively, and in compliance with federal and state laws. The Inspector General would be appointed by the Governor and serve a six year term. In addition, SB 878 directs the Inspector General to report annually to the

Governor and Legislature with a summary of his/her findings, investigations, and audits and requires that this summary be posted on the Inspector General's Internet website.

Many states have successfully adopted the OIG model, including New York and Pennsylvania, and many major cities employ an Inspector General to oversee transportation projects. The federal government employs OIGs in most of its departments and agencies, charging them with identifying fraud, waste, abuse, and mismanagement within its parent agency. The US Department of Transportation relies heavily on its OIG to ferret out fraud as well as recommend areas of improvement and efficiencies.
