Ian trained at The Royal Academy of Dramatic Art in London. In England, he worked in Repertory Theater, London's West End (where work included the title role in Jack the Ripper), television (including the Laurence Olivier King Lear), and film.

He has performed his one-man play "From Wharf Rats to Lords or the Docks" nearly 200 times to about 50,000 people across America and in Canada, Hawai'i, England and Australia. Legendary filmmaker Haskell Wexler filmed a live performance at the Warner Grand Theater, San Pedro in front of 1000 people. It aired on PBS in 2009/2010, presenting the story to 150 million people..

"To Begin the World Over Again: the Life of Thomas Paine" challenges many of the perceptions and assumptions about Paine and throw new light on the birth of America, as well as on the French Revolution and the Age of Reason. Thomas Paine was the one truly radical Founding Father of America, a man who changed the face of the world through his writings. "Common Sense" inspired the American Revolution, "Rights of Man" defined the French Revolution, and then "The Age of Reason" called on us to use our ability to reason as the basis for our beliefs and morality.

I have watched "From Warf Rats to Lords of the Docks" a number of times and always come away with new understanding of what my relatives went through in the west coast labor struggles as they helped build the International Longshore-Warehousemen's Union in the 1930's, 40's and 50's. I have also read a bit about Thomas Paine and find him one of our more interesting founding fathers. # **Reports from our Elected Officials**

#### **Congressman Jerry McNerney**

#### **Congressman McNerney Fights For The Delta Region**

Oct. 4, 2011

Washington, D.C. – Today, Congressman Jerry McNerney (CA-11) continued the charge against a new canal that would take water out of the Delta region. Joined by Representatives Mike Thompson, George Miller, Doris Matsui, and John Garamendi, Congressman McNerney met with Jerry Meral, the Deputy Secretary of the California Natural Resource Agency to express his grave concern over any Bay Delta Conservation Plan (BDCP) that would adversely affect the Delta Region. Meral is the senior state official who oversees the BDCP.

"I will continue to be a strong advocate for the people of the entire Delta region to ensure that the water resources and their quality remain in place," said Congressman McNerney. "Steps must be taken now to ensure that the BDCP serves the best interests of our region, and I insisted that the voice of the Delta be heard."

Since 2007, Rep. McNerney has spearheaded the fight against a new conveyance system-such as a peripheral canal or tunnel-- that would take large amounts of water from the Delta. Last month, he sent a letter to the Department of the Interior insisting that the final BDCP benefit the Delta region. The letter strongly opposed any aggressive measures that would adversely affect the Delta.

"Agriculture is the life blood of the Delta region, and I will fight to protect the livelihood of our farmers, families and small businesses. I thank my colleagues in the region for once again joining me in fighting for the well-being of the people in the San Joaquin Delta region," said Rep. McNerney. "As I made clear to the Bay Delta Conservation Plan officials, we will not accept a new canal that does not have the buy in of the Delta communities."

Representatives Miller and Thompson echoed McNerney's dedication to fighting for the residents of the Delta region:

"Needlessly rushing the scientific review of the Bay Delta Conservation Plan is simply irresponsible, and that is what I told the Bay Delta Conservation Plan officials today," said Rep. Mike Thompson (CA-01). "We know all-too-well the consequences of bad water policy combined with impractical deadlines. In Humboldt and Del Norte Counties, expedited review of

the Klamath River project resulted in the death of 68,000 Chinook Salmon. Are we really considering walking down the same road again? We need sound, science-based solutions that don't harm our wildlife or environment."

"This was a much-needed meeting, but it doesn't yet solve the problem. We are very concerned that Bay-Delta interests are not being treated as equal partners – despite clear direction from the state legislature that a restored Bay-Delta and a reliable water supply must be co-equal goals. The state of California, the federal agencies, and the exporters who are seeking the Bay-Delta's water have stumbled badly over the way that this Bay-Delta Conservation Plan is being put together -- behind closed doors, and without full and fair participation," said Rep. George Miller (CA-07).

#### Miller Requests Immediate Hearings on Job Creation Proposals

#### Dear Chairman Kline:

Last night before a Joint Session of Congress, President Obama proposed the American Jobs Act, a package of proposals to create jobs immediately and spur future economic growth. Given the urgency of our nation's job situation and since the House Education and the Workforce Committee has jurisdiction over a number of the proposals in this plan, I respectfully request that you immediately schedule committee hearings on these important initiatives outlined by President Obama.

During the recent August recess, Members heard from their constituents. The message was loud and clear. The American people share the President's sense of urgency that Congress must act together and act quickly to create jobs.

Economists agree that creating jobs is the first, most important step we need to take to grow the economy, reduce the deficit, and keep Americans working. Creating jobs now is the key to fixing nearly every other economic problem America faces today.

Businesses have repeatedly pointed out that their hiring has stalled for lack of demand. By taking measures to directly put more Americans back to work, we grow demand. Workers are consumers.

As you know, in the wake of the worst financial crisis since the Great Depression, the country's unemployment situation is in dire need of attention. With more than 14 million Americans officially out of work, unemployment remains above 9 percent. A staggering 6.2 million Americans have been unemployed for more than 6 months. This long-term unemployment threatens to knock these workers permanently out of the middle class. Some sectors have been hurt worse than others. The construction industry's nationwide unemployment rate stands in

double digits. Public service jobs, like teachers, firefighters, and police, continue to suffer from the downturn and its impact on state and local budgets. Just this summer, 85,000 school personnel received pink slips, bringing the total of education workers losing their jobs since September 2008 to 290,000. Those job losses result in larger class sizes, not to mention damaging pauses in teaching careers we should be nurturing.

The President proposed several items within our Committee's jurisdiction that can save and create jobs now and help the unemployed find work. Some significant measures in our jurisdiction include:

- A school modernization program, benefiting at least 35,000 public schools, would put
  construction workers to work repairing schools, upgrading science labs, and making
  classrooms internet-ready. A portion of this program would be used for modernizing
  facilities in our nation's critical community college system.
- Education jobs funding would stop the layoffs of 280,000 teachers and support the hiring of tens of thousands more.
- An employment law reform would prohibit employers from discriminating against unemployed workers when hiring.
- A Pathways Back to Work fund for low-income individuals would provide for subsidized employment, support for innovative training programs, including at community colleges, and summer and year-round job opportunities for youth.
- The long-term unemployed can benefit from measures to improve reemployment assistance, and work-share proposals intend to save the jobs of workers who would otherwise be laid off.

The President's proposals have enjoyed bipartisan support in the past. For example, you have long called for reauthorization of the Workforce Investment Act. We should act on reauthorization and reinvigorate reemployment assistance and job training efforts. The important question is whether this Congress can work together with our President to help start creating jobs now. Congress must put partisanship aside and seize this moment to move our economy forward. It is well past time for this Congress to refocus on jobs and take action to grow and strengthen America's middle class. The President's plan deserves to be heard. Our Committee should schedule hearings on his proposals as soon as possible. I look forward to hearing from you on how our Committee will respond to the President's call to action and to working with you on these matters.

#### **Congressman John Garamendi**

Rep. Garamendi Rejects House Republican Chair's Defeatist Statement that "America Can't Compete with China" In Clean Energy Race

Garamendi Continues to Push Make It In America Jobs Agenda

WASHINGTON, DC – Congressman John Garamendi (D-Fairfield, CA), the author of Make It In America legislation that would create jobs and help America compete in the modern Clean Energy Race, today rejected the suggestion by the Republican House Energy and Commerce subcommittee on Oversight and Investigations Chairman Cliff Stearns that "we can't compete with China to make solar panels and wind turbines."

"Every great jobs-creating technological advancement in American history – cars, space travel, and the Internet included – were rebuffed by naysayers that preferred to raise the white flag of surrender before even trying," **Congressman Garamendi said**. "The solar industry was born in America and is responsible for 100,000 American jobs. With commonsense policies like Make It In America buying preferences, we can do much to once again become the world's leader in solar production."

**Garamendi added**, "The America I know and love is not a nation of quitters. Some say we can't afford to compete with China; I say we can't afford to surrender to China or any other nation. And we certainly can't afford to continue relying on dirty fossil fuels from countries that don't share our priorities or values."

Congressman Garamendi is the author of the Manufacture Renewable Energy Systems: Make it in America Act (H.R. 487), which would create American jobs by ensuring that taxpayer dollars are spent on American-made renewable energy systems, including solar, wind, geothermal, and biofuels. Phased over a four year period, the bill requires the federal government and any state government buying renewable technologies with federal funds to purchase renewable sources of energy grown, produced, or manufactured with 100% American content. It also requires any company taking advantage of the Investment Tax Credit and the Production Tax Credit to buy 100% American content within four years after the bill becomes law.

As a California state legislator in the 1970s, Garamendi also authored the first state clean energy tax credit in the nation, which was directly responsible for wind energy production in the Altamont Pass near Livermore and the Montezuma Hills near Fairfield.

#### State Senator Mark DeSaulnier

#### DeSaulnier's Jobs Bill Approved by Legislature

Friday, September 09, 2011 Senate Bill 734 (DeSaulnier) Supports Job Training of California Job Seekers

SB 734 (DeSaulnier) was approved today by the Assembly with a 49-27 vote and by the Senate with a 25-15 vote. The measure prioritizes the spending of Workforce Investment Act (WIA) money for quality job training programs and services for unemployed workers.

"Workers in California face the toughest job crisis since the Great Depression," said DeSaulnier (D-Concord). "With declining state revenues and pressure on public resources, it is crucial that every dollar of federal workforce funds is invested in high quality job training that connects workers to good jobs."

California receives almost \$500 million annually in WIA dollars for job training and employment services for youth, disadvantaged adults, and dislocated workers. The majority of this money (85%) is allocated to 49 local Workforce Investment Boards (WIBs) which develop policies for how local WIA dollars are invested.

Despite the need for targeted and effective training, local WIBs in California spend very little WIA funds on skills training. On average they invest just 20% of their federal funds on job training services. A third of them spend less than 11% on training and many invest nothing at

all. Faced with a similar problem, other states, including Florida, Illinois, Michigan and Wisconsin, have all adopted policies that require more local WIA funds to be dedicated to training. For example, Florida requires that local WIBs spend at least 50% of their WIA funds on training.

SB 734 requires local WIBs to increase spending of their Adult and Dislocated Workers Fund on quality programs and services that provide workers with job training. Under this bill, spending would increase annually to a minimum of 30% of the Fund in 2016 and thereafter.

SB 734 is supported by and co-sponsored by the California Labor Federation, California Manufacturers and Technology Association, and State Building and Construction Trades Council. The bill will be sent next to the Governor for consideration. He has until October 9<sup>th</sup> to act on this bill.

# Buchanan Bond Initiatives Reform Bill Signed into Law by Governor Tuesday, October 04 2011

(Sacramento, CA)— Assemblymember Joan Buchanan (D-Alamo) is pleased to announce that Governor Brown has signed Assembly Bill 732 into law. The bill passed through both houses of the Legislature with unanimous support.

AB 732 requires an explanatory table, which will appear in the ballot pamphlet, summarizing the Legislative Analyst's estimate of the net state and local government fiscal impact of state-wide bond measures. The bill, which stems from a recommendation by the Little Hoover Commission, would provide additional clarity to voters on state-wide bond measures.

"The 2009 Little Hoover Report suggests improving the information given to voters in order to help them have a clearer picture of the implications of approving or rejecting a state bond measure. One specific recommendation is to "include in the voter guide an easy-to-read chart or report card developed by the Legislative Analyst's Office that assists voters in more completely understanding the fiscal context of and potential trade-offs that result from their decisions on the ballot," stated Buchanan.

"I believe that during such difficult fiscal times, voters need as much information as possible when voting on measures that will lead to decades of fiscal obligations," Buchanan continued. The Governor announced that he had signed AB 732 along with a group of reform bills all designed to "protect the state budget and strengthen fiscal stability in California."
