Congress may consider new way to help jobless veterans

WASHINGTON, D.C. June 21, 2011 11:53am

- Bill would help ensure that federal contractors are really hiring veterans
- 'This is an important step towards a more transparent system'

The Secretary of Labor would be required to establish a website with information about the number of veterans employed by federal contractors under a bill introduced in Congress Tuesday by Rep. Jerry McNerney, D-Pleasanton.

Mr. McNerney sees it (H.R. 2243) as a way to better scrutinize hiring practices of companies with federal contracts.

Current law requires contractors to file reports with the Secretary of Labor on the number of veterans they hire

and employ, but this information is not easily accessible to the public, he says.

"The Veterans Employment Promotion Act will ensure that information on the number of veterans employed by federal contractors is widely available to the public. This is an important step towards a more transparent system and will help ensure that our veterans have access to good jobs," says Mr. McNerney.

A 2009 hearing by the Subcommittee on Economic Opportunity examined federal contractor compliance with veterans' employment laws. During this hearing, representatives of several Veterans Service Organizations recommended better enforcement and oversight.

Congressman John Garamendi

Natural Resources Committee Adopts Garamendi Make It In America Amendment

WASHINGTON, DC – The House Natural Resources committee today adopted an amendment authored by Congressman John Garamendi (D-Walnut Creek, CA) which would encourage hydropower materials and equipment to be made in America. The amendment was part of H.R. 795, the Small-Scale Hydropower Enhancement Act, which calls for the Secretary of the Interior to perform a study that looks at hydropower capabilities of one megawatt or less. Congressman Garamendi's amendment would direct the study to discuss the "availability and importance of using materials and equipment produced and manufactured in the United States." The Committee approved the amendment by a unanimous voice vote. A pdf of the amendment is available here.

"In America today, fourteen million workers are out of a job through no fault of their own," Congressman Garamendi said. "Even in this difficult economic climate, we have reason to hope and a reason to act. We can create manufacturing jobs and Make It In America again."

Garamendi added, "When we invest American taxpayers' money on national improvements, that money should be used to put Americans back to work – and that's exactly what my amendment aims to do. I commend my Republican and Democratic colleagues on the committee for adopting an amendment into H.R. 795 that could create jobs for Americans who desperately want employment."

State Senator Mark DeSaulnier

overnor Signs DeSaulnier Legislation to Reduce Retirement Costs for Contractors County, *Monday, July 11, 2011*

enate Bill 373 Permanently Extends Cost-Effective Retirement Option

overnor Brown has signed SB 373 (DeSaulnier) to allow for the continued use of a negotiated compromise that wers Contra Costa County's public safety retirement contribution. This compromise, commonly referred to as Tier, was negotiated in 2006 between the County and public safety employees represented by the Contra Costa ounty Deputy Sheriffs Association. SB 373 will permanently extend Tier C public safety retirement benefits in the ontra Costa County Retirement System. The Tier C option was set to expire on January 1, 2012 without this gislation.

Fier C is a less expensive retirement benefit that has helped to reduce the county's structural pension costs," said enator Mark DeSaulnier (D-Concord). "The extension of Tier C preserves the current compromise that is fair to

oth parties and helps the county's fiscal situation."

2006, SB 524 (Torlakson) memorialized a compromise between the Board of Supervisors and employees presented by the Deputy Sheriffs Association which created a new public safety retirement tier, Tier C, for heriff's employees hired after December 31, 2006. SB 524 included an expiration date of January 1, 2012 to allow ne to determine if Tier C would deliver cost savings as intended. Both parties agree that Tier C is working very ell.

B 373 was sponsored by the Board of Supervisors and supported by the Deputy Sheriffs Association. This bill was nanimously approved by both the Senate and the Assembly before being signed into law.

Assembly Woman Joan Buchanan

Buchanan Honors The Brass Bear Deli as 2011 Small Business of the Year

(Sacramento, CA) - Assemblymember Joan Buchanan (D-Alamo) today recognized Mehran Hamzeh, owner of the Brass Bear Deli, as the Small Business of the Year for the 15th Assembly District.

"Mehran and Sheida Hamzeh are wonderful individuals and I am proud to honor them as the Small Business of the Year," Buchanan said. "Brass Bear sandwiches are excellent and Mehran and Sheida are huge supporters of the community. They are an important part of what makes the San Ramon Valley great."

The Hamzeh family has owned and operated the Brass Bear Deli in Alamo for 30 years. In 2009, the Hamzehs opened a second location in Walnut Creek. Hamzeh has built a strong business that helps contribute to the local economy by hiring high school and college students to work at the deli part time. He estimates that over 250 young adults in the San Ramon Valley have worked for him since he first opened the doors of the Brass Bear Deli, and he has enjoyed watching them grow.

"It is important to recognize the Brass Bear's continuous service to the young people in our community. Sheida and Mehran have given our youth a chance to work, learning responsibility and leadership. They are incredible role models for our kids," Buchanan said.

The Brass Bear Deli is open 7 days a week, 362 days a year. In addition to their full-service deli, they also provide catering service.

The Small Business of the Year awards are hosted by the California Small Business Association. In 2000, the Assembly resolved that the final Wednesday in May each year would be declared "California Small Business Day."

A message from California Assembly Member Joan Buchanan AD 15 7/11/2011

Fellow Democrats,

As all of you know, June was an eventful month.

I believe the people of California are tired of the polarization that exists in our state and national capitol and desperately want their government to work again. They want us to use common sense and solve problems. That is why, like it or not, they passed initiatives to change how we draw districts, passed the open primary, and, most importantly, passed Proposition 25 which allows the legislature to pass a budget with a simple majority vote.

Having served on a local school board for almost two decades, I understand how important Proposition 25 is because local governments and agencies cannot complete

their planning and budgeting until the State does its job. I also understand the importance from the perspective of a state assembly member. Constantly giving permanent tax cuts for temporary revenues is not a good budgeting practice. Tax cuts should be targeted to help infant industries, but too often, tax cuts become a company's profit margin. That is not good business for anyone.

So 2011 became the year that the legislature passed an on-time budget with a simple majority vote in many decades. The Governor proposed a budget in January and in his May revision that included extension of temporary revenues. This was because he recognized our obligation to resolve the structural deficit, pay off our mountain of debt, and provide essential services like education and public safety. This required a two-thirds vote and, unfortunately, the Governor was not able to secure two Republican votes in each house.

Despite the "celebration" of having an on-time budget, let there be no mistake that this budget includes significant pain. There were deep cuts to Health and Human Services and higher education and a realignment of services from the state to local agencies where they can be provided more effectively. Funding for K-12 schools remained at the 2010-11 level. The budget also included the elimination of Redevelopment Agencies along with a second bill that allows local agencies to opt into a new RDA with specified conditions. This is controversial, will require cleanup language, and will be challenged in court. Finally, the budget assumes additional new revenues based on increases in May and June receipts. If these revenues do not materialize, automatic cuts will be triggered in 2012.

Overall, 2011-12 spending will be at the 1972-73 level. The budget will close 75 percent of the structural deficit, but there remains much work to do. We still need to close the remaining 25 percent of the structural deficit, pay off over \$20 billion in borrowing and \$15 billion in deferred payments, and repay the federal government for \$11 billion in unemployment insurance loans. If we don't want to leave this debt to our children, some type of temporary revenues will need to be explored in the future.

US Congressman Pete Stark on Libya



The U.S. has now been involved in Libya for over 60 days. We have provided 93 percent of the cruise missiles, 66 percent of the personnel, half the ships, and half the planes. All this military might, yet we were never attacked. We also never had a constitutionally required authorization for the use of military force. We are at war in

Libya – one that I oppose in the strongest terms – yet we never had a declaration of war.

Today I voted in support of H. Con. Res. 51, introduced by Rep. Dennis Kucinich (D-OH), which would have required the President, pursuant to the War Powers Act, to remove our troops from Libya within 15 days. Congress would then review how our nation should move forward. I cosponsored this important resolution, but to my great disappointment, it failed by a vote of 148-265. Sincerely,
