# Congressmen demand that Bay Delta Conservation Plan be fair and equitable

- Call the current delay the 'the last, best opportunity' to improve the plan
- Too many back-door deals, says congressman

The Bay Delta Conservation Plan, which could shape the course of California's history through the rest of the century and beyond, must be fair and equitable, say a group of California members of Congress.

The state has delayed releasing the controversial plan. On May 4, the Natural Resources Agency announced that environmental review documents for the Bay Delta Conservation Plan will not be ready for release by the end of June as originally planned.

Calling the most recent BDCP delay the "last, best opportunity to stand up to... unreasonable demands," Reps. Jerry McNerney, George Miller, Mike Thompson, Doris Matsui, and John Garamendi, are demanding specific steps be taken for the plan to move forward in a fair and transparent manner.

The five members from the California congressional delegation have been vocal in calling for changes to the BDCP and have demanded that any plan has significant input from the Bay-Delta region.

"We recognize that some are now calling for an immediate decision, but we believe that it is critical to get this right; a rushed and inadequate Bay-Delta planning effort will lead to increased litigation, uncertainty, and expense," they say n letters sent Wednesday to Gov. Jerry Brown and Secretary of the Interior Ken Salazar.

"I will not accept any plan for the Delta that is harmful to the farmers, families, and small business owners in the Delta region. To date, the planning process for Delta water has been unduly influenced by wealthy water contractors from south of the Delta who would steal our water, costing us millions of dollars and countless jobs," says Mr. McNerney.

"This delay provides an opportunity for the state and federal governments to stand up to the water contractors and ensure that the BDCP includes the input of our region," he says.

Mr. Miller says that more than five years into the process, the Bay Delta Conservation Plan still hasn't met basic legal or scientific requirements.

"This is the last chance to fix it, and that's why this delay is so important: it gives the scientists time to get it right," says Mr. Miller. "The Bay-Delta's health is key to California's future – we can either work out a good plan that reduces reliance on the Delta, or we can end up with increased litigation, uncertainty, and expense."

Mr. Thompson says there have been too many back-door deals that put the interests of South-of-Delta water contractors before all others."

Many of our families and small businesses that depend on the Delta would have their livelihood stripped away and the Delta's diverse wildlife would be destroyed if these politically driven deals were put in place," Mr. Thompson says. "Federal and state officials need to use this delay to come up with fair and transparent plan that is based on sound science so that our communities, businesses, fish, wildlife and environment in the Delta and north of the Delta are not harmed."

Ms. Matsui says the plan must reflect due diligence and equitable treatment to all those affected. "I want to see the federal and state agencies take this opportunity to put forward a process and a plan for the Delta region that recognizes the input they've received not just from south of Delta interests, but north of Delta interests as well. Our state can't afford to get this wrong," she says.

Mr. Garamendi says that in addition to using the best available science, "we must focus on conservation, storage, and recycling to preserve our state's ecosystems and to meet the water needs of nearly 40 million Californians."

### Miller to be recognized by leading disability rights organization

Miller to receive Kennedy Award for lifetime achievements on behalf of all people with disabilities

WASHINGTON, DC – U.S. Rep George Miller (D-Martinez) will be honored today by Disability Rights Education and Defense Fund (DREDF) for his many years of work to advance the rights of all people with disabilities. Miller will be honored Tuesday night at the organization's 33rd anniversary celebration and will participate in a panel discussion on the disability rights movement and the challenges the disability rights movement currently faces.

Miller will receive the Edward M. Kennedy Award that honors individual lifetime achievements in advancing the rights of all people with disabilities. This award is named after its first recipient, the former senator from Massachusetts. Senator Kennedy's unwavering commitment to the rights of all Americans, including the 54 million with disabilities, has produced landmark civil rights legislation, including the Americans with Disabilities Act (ADA).

Miller, appreciative of the award, thanked DREDF for their years of work advocating for civil rights for people with disabilities. "It is an honor to be recognized by the Disability Rights Education and Defense Fund," Miller said of the award. "Senator Kennedy was a true champion for students and people with disabilities, and his work has made a real difference in the lives of so many. And this organization's work in the fight for civil rights for people with disabilities is an important part of the victories we've seen in the last 35 years. I have worked with good people at DREDF for decades and I will continue to work them and the entire disabilities community to support smart policies that protect and improve services for children and adults with disabilities."

Miller has a long history of fighting on behalf of people with disabilities and is a staunch supporter of civil rights for people with disabilities. Early in his career, he convened a Congressional "hearing" with protesters led by Judy Heumann and Ed Roberts at the federal Health, Education and Welfare department building (now known as HHS) in San Francisco demanding that Section 504 be implemented. At the time, Miller spoke out against proposed "separate but equal" facilities for people with disabilities.

Throughout his tenure in Congress, Miller has championed legislation of significance to people with disabilities, including the Education of All Handicapped Children Act of 1975 (now known as IDEA). Working with Sen. Kennedy on what became known as the "No Child Left Behind Act," Miller insisted that schools be held accountable for the achievement of students with disabilities.

Most recently, Miller has championed the Keeping All Students Safe Act to establish minimum standards for restraint and seclusion in schools and to keep students safe in

the places where they learn. Studies show that tens of thousands of children are subject to dangerous seclusion and restraint practices in schools.

The Disability Rights Education and Defense Fund, founded in 1979, is a leading national civil rights law and policy center directed by individuals with disabilities and parents who have children with disabilities.

#### **Congressman John Garamendi**

# Garamendi Votes Against Escalation of Afghanistan War, Indefinite Detention, and Wasteful Spending

FAIRFIELD, CA – Congressman John Garamendi (D-Fairfield, CA), a public servant for more than four decades, spent less of his office budget than more than 90% of his House colleagues, according to data released by Congress. In 2011, the Office of Congressman Garamendi spent 77.8% of its available budget, making the office more frugal than 395 of 436 offices in the House. This demonstrated fiscal restraint comes despite the need for three district offices to serve the sprawling 10th Congressional District and higher than national average costs in Northern California.

"I want to see less money spent on Congress and more resources paying down our deficit and investing in our schools, roads, health coverage, and veteran's services," Congressman Garamendi said. "I've balanced the checkbook for the family ranch. I know how to make more with less. I'm proud that we managed to stay so under budget while still maintaining robust communications with and support for 10th Congressional District residents."

In 2011 and early 2012, Garamendi hosted more than a dozen in person and telephone town halls, in addition to a to resource fairs for job seekers, veterans, seniors, social services, and small businesses, and a Post-Traumatic Stress Disorder (PTSD) Workshop for counselors and mentors. In addition, Garamendi has hosted at least one town hall in 11 cities in the 10th Congressional District since entering Congress.

# **Stark Praises Administration for Initial Action on His Call to Stop Abusive Medical Debt Collection Practices**

WASHINGTON -- Today, Rep. Pete Stark (D-CA), Ranking Member on the Ways and Means Health Subcommittee, issued the following statement in response to the news that the Administration has taken a first step on <u>his request for investigation into a debt collector</u> that allegedly has been demanding payment from patients in emergency rooms and at hospital bedsides (first reported by the <u>New York Times</u>: In Congress, a Move to Look Into a Medical Debt Collector).

Rep. Stark: "I'm very pleased that the Administration has quickly taken a first step to respond to my request for investigation into the potentially abusive debt collection practices being used inside hospitals. It appears that Accretive Health has been going after patients in emergency rooms and at their hospital bedsides. This is despicable behavior, but of most concern, their actions may bar patients from getting needed care and violate important patient protection laws.

"Unfortunately, Accretive cancelled a meeting last week during which we had hoped to hear their explanation. We're exploring whether their alleged practices are common within the medical debt collection sector or whether Accretive is an outlier that appears to be profiting from questionable practices. In either case, these abuses must be stopped."

Marilyn Tavenner, Acting Director of the Centers for Medicare and Medicaid Services, has <u>asked major hospital associations to warn their members</u> about the serious concerns and consequences of hospitals permitting debt collectors to violate the Emergency Medical Treatment and Active Labor Act (EMTALA). Stark was the main architect of EMTALA, which ensures patients cannot be turned away by an emergency room regardless of their ability to pay. #### **State Senator Mark DeSaulnier**

#### DeSaulnier Meets with Joint Policy Committee

May 18, 2012

Today Senator Mark DeSaulnier, Chair of the Senate Transportation and Housing Committee (D-Concord), met with the Joint Policy Committee (JPC) to discuss the future of regional governance in the San Francisco Bay Area. At the JPC meeting at the MetroCenter Auditorium in downtown Oakland, DeSaulnier briefed the JPC Members on his legislation, Senate Bill 1149, and the need to reform regional governance.

"I look forward to working with JPC members as well as with the members of the various regional agencies and advocates for housing, transportation, business, economic development, the environment, and other regional issues. Together we can participate in an honest and forthright attempt to reform regional governance," said DeSaulnier. "Consequently, I offered to withdraw my current legislation to allow more time for all of us to have a robust public discussion about regional governance in the San Francisco Bay Area."

SB 1149 would have created the Bay Area Regional Commission to coordinate regional planning and policy decisions dealing with transportation, housing, air quality, sustainable community strategies, economic development, and other regional issues. SB 1149 represents the first proposed reforms in regional governance since the Metropolitan Transportation Commission (MTC) was created in 1970.

"I thank Senator DeSaulnier for his sincere efforts on this important issue," said John M. Gioia, District 1 Supervisor, Contra Costa County and Chair of the Bay Area Air Quality Management District. "I am confident that we can identify common ground and develop critical reforms that will create a regional governance model for other California metropolitan areas." "We all need to come together to achieve reform that is good for the entire region," said Tom Bates, Mayor of Berkeley and Chair of the Joint Policy Committee. "In the next few months we

need to see if we can work together and come up with some ideas that will enhance regional governance in the Bay Area."

"We all agree that the San Francisco Bay Area needs a regional governance structure that meets the needs of the communities we serve," said Julie Pierce, Clayton City Councilmember and Vice Chair of the Association of Bay Area Governments. "Our challenge will be to reform the system in a manner that not only meets the region's short term needs, but also reflects the needs of generations to come."

"The San Francisco Bay Area is the fourth largest metropolitan area in the nation. It is the most diverse and innovative place on earth," said DeSaulnier. "Regional planning in our area needs to reflect that diversity and innovation. After a months-long collaborative process, our hope would be to introduce comprehensive regional reform legislation in the next Legislative Session."

Below is a list of principles underlying DeSaulnier's regional governance reform efforts:

- 1. Respect the integrity of the existing regional agencies.
- 2. Provide policy oversight to ensure the development of a coherent multifunctional regional plan.
- 3. Prepare a 20-year regional economic development plan to be integrated into the multifunctional regional plan.
- 4. Increase public access to the regional process at the community level.
- 5. Integrate regional management and reduce the duplication of overhead functions, such as human resources, procurement, and the like, to achieve cost savings.

The Bay Area is a growing region of 7.5 million people. Currently, the Joint Policy Committee (JPC) coordinates the regional planning efforts of the Association of Bay Area Governments (ABAG), the Bay Area Air Quality Management District (BAAQMD), the Bay Conservation and Development Commission (BCDC) and MTC. However, the JPC has no real authority to oversee the myriad agencies of regional governance.

SB 1149 would have corrected this by eliminating the JPC and establishing the Commission in its place. The Commission would have had increased authority and would have provided a regional policymaking process to ensure that regional policies are developed within a consistent framework.

# Assemblymember Joan Buchanan Appointed Chair of Special Committee on Governor's Reorganization Plan

May 16, 2012

(Sacramento, CA)—Assemblymember Joan Buchanan (D-Alamo) announced that Assembly Speaker John A. Pérez has appointed her Chair of a new special committee that will assess the Governor's Reorganization Plan No. 2, a plan that will reorganize several agencies and departments of the executive branch.

"The Governor has presented the Legislature with a broad proposal to streamline the administrative functions of the Executive Branch," Buchanan stated. "I look forward to our

discussions on how to make California state government as efficient, accessible, and responsive to the needs of the public as possible."

Assemblymember Buchanan is currently the Chair of the Budget Subcommittee on State Administration, which has held a number of hearings in the past few months to evaluate some of Governor Brown's other proposals to reorganize the executive branch. She is also the Chair of the Select Committee on Government Efficiency, Innovation, and Technology.

The committee membership will include members with diverse expertise in the areas the Governor has proposed to reorganize. Assemblymember Katcho Achadjian (R-San Luis Obispo) will serve as Vice Chair, with Assemblymembers Bill Berryhill (R-Stockton), Roger Dickinson (D-Sacramento), Linda Halderman (R-Fresno), Isadore Hall (D-Los Angeles), Mary Hayashi (D-Hayward), Alyson Huber (D-El Dorado Hills), Kevin Jeffries (R-Lake Elsinore), Bonnie Lowenthal (D-Long Beach), V. Manuel Pérez (D-Coachella) and Norma Torres (D-Chino) filling out the rest of the special committee's membership.
