Donors cannot be reimbursed for their contributions. Contributions from individuals, partnerships, unincorporated sole proprietorships, and political and candidate committees registered with the FEC will be deposited into the CCCUDC Federal Account (FEC ID#: C00379834) unless otherwise designated. These funds will be used in connection with Federal elections and subject to the limits and prohibitions of the Federal Election Campaign Act. Contributions from corporations, labor union and political committees registered with the California Secretary of State will be deposited in the CCCUDC State Account (FPPC ID #: 1245376) to be used in connection with non-federal elections. California law permits contributions up to \$30,200 per calendar year for use in supporting state elections. There are no limits on contributions used for purposes other than supporting state candidates. Federal election law requires political committees to report the name, address, occupation and name of employer for each individual whose contributions aggregate in excess of \$200 in a calendar year.
